CPO-11 PRIVACY NOTICE

CPO-11 Organizing Committee hosts the 11-th International Conference on Charged Particle Optics, CPO-11, which will take place in Fukui-shi, Fukui, JAPAN, from Oct. 16 to 18, 2024. CPO-11 Organizing Committee consists of the secretaries of Electron Optics Design Technology Subcommittee of the Japanese Society of Microscopy (1-21-13-402 Takadanobaba, Shinjuku, Tokyo 169-0075, Japan). This privacy policy will explain how our committee uses the personal data we collect from you when you use our website to register for CPO-11.

1. Categories of personal data

We hereby inform you that we collect, use and process the following categories of your personal data:

- Name
- Address
- Affiliation and position
- Gender
- Email address
- Accompanying person

2. Legal basis and purpose:

As per Article 6(1)(f) GDPR, we hereby inform you that we use your personal data for the purpose of providing you following services:

- Making accommodation or hotel arrangements
- Making transportation arrangements
- Making restaurant arrangements or other food arrangements
- Making other services arrangements
- Supporting you with the tours or with preparations for the tours
- Managing the itinerary or the preparation of the itinerary
- Considering, entering into, or performing contracts or other relationships
- Responding to your queries or requirements
- Maintaining our relations with you
- Responding to your queries
- Providing information on presentations at the conference

Furthermore, participants' personal data will be converted into a form that does not allow individual participants to be identified, and will be used for conference management and statistical purposes.

3. Retention periods

4. Data storage and transfer

CPO-11 Organizing Committee may share participants' personal data with the conference's management company and other companies that provide services to participants, such as hotels, restaurants, transportation providers, travel agencies, etc. within and outside the EEA. Additionally, if your company is located outside the EEA, we will transfer your personal data on appropriate legal grounds based on company regulations and social compliance.

5. Prior consent

Where we require access to your Personal Data that GDPR considers Sensitive, we will seek separate explicit consent from you prior to obtaining that data.

6. Your rights
